Introduction/Overview

Alliance logistics Incorporated now Alliance Logistics Oil and Gas Corporation (A-LOG) is a Liberian owned business established in 2016 and engaged in Waste Management, Transportation & Distribution of Petroleum products utilizing its fleet of 6 (six) tank-trucks, which made the company well acquainted with the Liberian energy terrain. In 2019, an amendment that established Alliance Logistics Oil and Gas Corporation (A-LOG) obtained. A-LOG gained its Petroleum Importation Licenses from the Liberia Petroleum Refining Company (LPRC) in July 2021 and has been trading locally since its inception.

As a result, A-LOG has now set the stage to engage in the importation and supply of petroleum products – Premium Motor Spirit (PMS) or Gasoline, Automotive Gas Oil (AGO) or Diesel, Heavy Fuel Oil (HFO), Lubricants and allied products, for resale to prospective clients on the Liberian market.

Additionally, the company has tangible connects and a cordial relationship with big players in the petroleum regulatory sector (LPRC) and the Government as a whole.

This business endeavor to serve the petroleum market in Liberia. With the Government of Liberia request for Liberian own companies to invest in the Importation and Supply of Petroleum to the Liberian market, we have exerted significate effort in the energy market.
